POOL PARTIES - 2010

During Hours Party (3 Hours)

Please note that more than one party may be scheduled for the same time/day. Tables cannot be reserved in advance as the pool will be open to all members during regular hours of operation.

- \$40.00 Party Fee (Member/Non-Member) for up to 20 People.
Your party fee must be paid at the time you reserve the date/time for your party.
- \$ 5.00 Per Each Guest (#21 and above)
- \$ 5.00 Barbeque Grill Reservation

After Hours Party -- 9:00pm – 12:00am (midnight)

Only one party may be scheduled on the same night. The pool gates Must be Locked at 12:00am (midnight) – please make sure that your area is cleaned, party fees are paid, and guests have left the fenced area by this time. You may request specific guards for your party but they are not guaranteed. The concession stand will not be open during these parties.

- \$ 90.00 Member Party Fee (for up to 50 guests) must be paid at the time you reserve the date/time for your party.
- \$110.00 Non-Member Party Fee (for up to 50 guests) must be paid at the time you reserve the date/time for your party.
- \$ 5.00 Per Each Guest (#51 and above)
- \$ 11.00 Per Hour, per Lifeguard. **2 Guard** minimum for parties of 1 – 50 guests; 1 guard per 25 thereafter (Guards must be paid in cash at the end of the party by Party Host/Hostess).
* Special Notice: If you have reserved more than the 2 minimum guards, please note that the Pool must receive notice 8-days prior to your party if you are not in need of 3 or more guards. You will be given the total number of guards you reserved and will be responsible for their payment if we do not receive such notice. Thank you for your understanding.
(Example: A 3-hour party with 2 lifeguards will be \$66 (\$33 for each lifeguard))

PARTY RULES

- All Pool Rules Apply. Please inform your guests of all pool rules. If you do not know the rules, please ask a pool staff member for a copy.
- All Party guests must sign-in at the Concession Stand Before entering the pool grounds. The Host/Hostess will be asked by pool staff to check the names on the sign-in form for accuracy; the pool staff may ask for a head-count during the event.
- Date/Time is confirmed upon payment of party fee and the completion of the party reservation paperwork.
- No private entrance fees or selling of alcohol are allowed.
- No balloons or confetti-type items are allowed; they can damage the pumps.
- A parent must be within 3-feet of the baby pool if a child is playing in it.
- Party Host/Hostess is responsible for any & all damages that may occur before, during, or after the party by one of their guests.
- All pool furniture must be put back in its original spot and wiped down if necessary.
- All trash must be picked up and bagged. Bags must be placed into large waste management trash cans.
- \$35.00 returned check fee. We will only run your check once. If it is returned to us we will not be able to accept another check payment from you; only cash, money order, or cashier's check will be accepted.
- The Pool Board Member(s) and Lifeguards on duty will be in charge of the pool and all surrounding areas and are responsible for the enforcement of all pool rules and regulations.
- Leon Valley has a Noise Ordinance – this must be followed by all members and guests.
- The Pool Board reserves the right to deny a party request for the betterment of the pool and/or membership at large.
